## **Pageant Agenda:**

- Contestant Check-in is from 12:30pm-1:30pm at the Days Inn in Batesville
- The pageant will start promptly at 2pm. If a contestant is late for his/her division, he/she will receive a 5 point deduction from his/her overall score.
- Spectator tickets are \$5 each. Contestants do not need to buy a ticket at the door. CASH ONLY
- If you would like to receive your scores and judges' comments, please bring \$5 cash to registration along with an addressed and stamped envelope to mail the scores in.

#### Awards:

A winner and alternates (amount of alternates pending contestant number entered in each division) will be awarded for each division. Age divisions will NOT be combined. Each division winner will receive a crown and sash. Alternates will receive a trophy. Each division will also have side awards that will be awarded with trophies. The side awards include Most Photogenic, Best Dressed, Best Personality, and Best Model. Four overall titles will also be given and awarded with a crown and sash. The Overall titles include- Overall Grand Supreme, Overall Most Beautiful, Overall Best Dressed, and Overall Most Photogenic. Overall Best Dressed and Overall Most Photogenic will be chosen from the Best Dressed and Most Photogenic side award winners in each division. Overall Most Beautiful is the contestant with the highest facial beauty score from all of the divisions. Overall Grand Supreme is the contestant with the highest overall score out of all of the divisions. By entering the pageant, all contestants are automatically entered into the side awards and overall titles. Contestants will not be double crowned. If a contestant has pulled for an Overall title, that contestant will receive a star on stage during his/her age division's awards and will not receive an alternate or title in their age division.

All age division winners and all Overall title winners will be REQUIRED to attend the Magnolia State pageant. After the pageant, you will be given your contract to sign. You are able to sell donation

tickets or ads to pay your fee for the state pageant, and you will receive more information when you receive your contract. Winners ages 0-11 will advance to the Little Miss Magnolia State Pageant held July 22-23, 2017 in Vicksburg, MS. Winners ages 12-up will advance to the Miss/Mrs. Magnolia State Pageant held November 17-19, 2017 also in Vicksburg, MS.
