Official Rules, Information and Eligiblity Requirements for the 2014 Miss Teen Radiance Pageant

The 2014 Miss Teen Radiance Pageant is an official preliminary to the 2014 Miss Teen Magnolia State Pageant.

Contestants and parents (where applicable) must read, agree and adhere to all contest rules and guidelines. LOCATION TBA SOON.

- 1. Contestants must be between the ages of 13 to 19 years old as of November 23, 2014.
- 2. Contestants must not be married nor have been married or pregnant. If pregnancy should occur or information is falsified, this is immediate grounds for disqualification. Should pregnancy occur at any time during the pageant or after (should the contestant win) this is immediate grounds for dismissal and/or disqualification.
- 3. Contestant must be of good health and good moral character.
- 4. Contestant must be in good academic standing and have a good school attendance record.
- 5. Contestant attests that she has not and will not engage in any activities which if disclosed to the public, would bring embarrassment, ridicule or defacement to the pageant sponsors, directors, affiliates or supporters in any form. Acts include but are not limited to the use of or sale of illegal drugs, nude or semi-nude dancing or modeling, illicit photographs or tapes, prostitution or any felony conviction or misdemeanor involving moral turpitude.
- 6. Contestant must be a resident of Mississippi or be attending school or working full time in Mississippi.
- 7. Contestant understands that no part of the \$60.00 registration fee is refundable at any point after application subsmission under any circumstances including disqualification.
- 8. Contestant agrees to fulfill all required obligations, which will not interfere with academic classes, should she win the pageant.
- 9. Contestant understands that the only fee the 2014 Miss Teen Radiance Pageant will pay the overall winner is the registration fee for the Miss Teen Magnolia State Pageant (Up to and not to exceed \$300). All other expenses related to participating in the Miss Teen Magnolia State Pageant are the solely the responsibility of the contestant.
- 10. Contestant and/or parent agress to provide transportation to and from all rehearsals and to the pageant.
- 11. Contestant must sign in and out for each rehearsal. Miss Teen Radiance Pageant officials are not responsible for contestants leaving or abusing rehearsal time. Contestants must be picked up no more than 15 mintues after rehearsal time ends. All contestants will be given a schedule of practice times.

- 12. Contestants under 18 should NOT leave rehearsals with anyone other than the parent or person indiciated in writing by the parent. Girls who do not obey this rule may be disqualified and appropriate authorities notified if discrepancies occur. This is for the safety of the girls and we must have your support.
- 13. Contestants and parents understand that **all rehearsals are closed**. Meaning only contestants, pageant directors and those individuals identified by the pageant directors will be allowed. This means that parents and other individuals bringing girls to rehearsals will have to wait outside of the rehearsal facilities or leave and return at the designated time to pick up their child.
- 14. Contestants are expected to attend all rehearsals. **Absolutely no cell phones on during rehearsal**. During rehearsal time, contestants must be in the designated area. Wandering, visiting, and/or loitering are not permitted.
- 15. Contestant and/or parents understands that due to legal liabilities, pageant directors, sponsors, and helpers are not able to provide transportation or to stay with girls more than 15 minutes after rehearsal unless prior arrangements have been made or in case of severe emergencies.
- 16. Contestants will model casual/sportswear, evening/formal wear and must have an outfit for the opening dance routine. The director will inform you on specifics for your opening number outfit.
- 17. Contestant may also be required to answer a question on stage. Questions will be drawn randomly. All contestants will be given a list of all questions at least two weeks prior to the pageant.
- 18. Contestants will not be judged on the opening dance but will be judged on the introduction.
- 19. Parents and other people with contestants are not permitted backstage during the pageant or one hour prior to the start of the pageant. Attendants will be provided to assit contestants backstage.
- 20. Videotaping and photographs are stricly prohibited as this distracts the judges and contestants. Professional pictures and videos will be available for a reasonable fee.
- 21. Neither Canann M.B. Church, the pastor, officiers, members, pageant directors, coordiantors, sponsors, helpers, assistants nor affiliates are responsible or liable for loss of or damage to individual property, accident, injury, or incidentials during or related to the pageant.
